# Reverse Transfer Convening:

## Key Resources and Materials

On June 8-9, 2015, representatives from the fifteen states funded as part of the *Credit When It's Due* initiative convened

in Indianapolis, Indiana to reflect on key issues facing states with the implementation of reverse transfer degrees and discuss sustainability for these efforts. The convening also included participants from 23 additional states engaged in reverse transfer. Attendees reviewed the latest research findings, discussed the policy contexts for reverse transfer and the role of technology in this work with a focus on emerging data system solutions. The convening was hosted by the *Credit When It's Due* Funders Collaborative.

## Reverse Transfer Headlines from Around the Country

#### Reverse Transfer Allows Students to Earn Degrees with Courses Already Taken

The Grand Island Independent | July 14, 2015 | "With the reverse transfer option, former community college students who are currently enrolled or have been enrolled at a university or state college campus may transfer the credits they've earned at the four-year institution back to the Nebraska community college they attended. Registrars evaluate the additional coursework and other community college requirements to determine whether students have met the requirements for an associate's degree."

#### UT Ramps Up Resources for Growing Transfer Student Population

Knoxville News Sentinel | July 12, 2015 | "The 2014-15 school year was also the first time students who transferred from Pellissippi to a four-year school could reverse transfer credits to earn their associate degrees while working on bachelor's degrees. About 75 students earned reverse transfer degrees in May."

#### Board of Regents OK Reverse Transfer Program

TheRidgefieldPress.com| June 27, 2015 | "Recognizing that higher attainment rates are required to meet Connecticut's workforce needs, the Board of Regents for Higher Education (BOR) this week voted to adopt a reverse transfer program for students enrolled in Connecticut State Colleges and Universities (CSCU) institutions."

#### Connecticut State Schools Adopt Reverse Transfer Program

Westfair Communications | June 29, 2015 | "A new rule will allow students who leave

Connecticut community colleges pursuing a bachelor's degree at a state university to still receive their associate degree after finishing the required credits. The state Board of Regents for Higher Education approved a reverse transfer program, which applies to students from any of the 12 state community colleges who switch to one of the four state universities or Charter Oak Stage College, an online college. Sixteen other states have launched or are launching this program, according to a Connecticut State Colleges & Universities press release."

#### Mott College and Walsh College Sign Reverse Transfer Agreement

Michigan Live | June 24, 2015 | "Mott Community College (MCC) President Beverly Walker-Griffea signed a reverse transfer agreement with Walsh College on Tuesday, June 23, at MCC's Flint campus. Students who transferred to a four-year college or university with at least 15 course credits earned at MCC, and who have earned a minimum of 35-45 credits earned at Walsh, can reverse transfer their credits to MCC and earn an Associate's Degree in Science or Art."
