Transformative Change Initiative

Trade Adjustment Act Community Community College Career Training Act

- American Recovery and Reinvestment Act (2009) -Largest federal investment in community colleges -~\$2B
- Workforce / CTE programs of study for TAA-eligible workers and other low-skilled adults
- Strategies to improve outcomes: retention, completion, credentials, and employment



TAACCCT seeks to...

- "Fund the development of innovative programs or replication of evidence-based strategies and award grants to eligible institutions to...
 - [Use] data to continuously assess the effectiveness of their strategies in order to improve their programming [and]...
 - Build knowledge about effective practices so that, in the future, institutions can replicate practices that are effective and identify and strengthen practices in need of improvement."

(TAACCCT Round One SGA, p. 2-3)



Implementation evaluation of the core strategies and programs of study


Impact Evaluation of short- and longer-term education and employment outcomes
